### Eligibility:

1. Spouse, life partner, child or stepchild of public safety officers killed in the line of duty whose death has been certified an official LODD by the Commonwealth of Virginia.
2. Applicant must have received a high school diploma or equivalency.
3. Applicant must be pursuing undergraduate education or professional certification from an accredited institute.
4. "Child" survivors must be under the age of 25 to request assistance.
5. Adult survivors must request assistance within five years of LODD.

1. If accepted into the VPSF Educational Scholarship program, you will be required to submit documentation, including receipts, for all expenses to be *reimbursed*, up to \$1,000 each semester.
2. VPSF will only reimburse expenses classified by the institution as “boarding and fees” or for the purchase of textbooks.
3. No expenses covered by other scholarships may be submitted for this award.
4. VPSF will certify your enrollment twice each academic term. Applicant must notify VPSF of any change in enrollment status. Payments will not be made to students who do not maintain the required course load to be considered a full-time student. If payments are made prior to a change in enrollment status, applicant may be asked to return payments to VPSF, or payments may be withheld for future semesters.
5. Applicant must provide a current copy of academic transcript each term to ensure good academic standing.
6. VPSF scholarship applicants are not required to meet a secondary education grade average to qualify for support, but must maintain a 2.0—or “C”—grade point average for scholarship-related courses. Applicants who do not maintain such an average may not receive payments.
